**EXECUTIVE ORDER NO. 2017 - 028**

**EXPANDING THE COMPOSITION OF THE LOCAL SCHOOL BOARD (LSB) OF THE  
MUNICIPALITY OF MONKAYO, COMPOSTELA VALLEY**

WHEREAS, pursuant to Republic Act 7160 otherwise known as the Local Government Code of 1991 the Local School Board is a mandatory council which focuses on the welfare and matters relating to the good cause of quality education in the locality;

WHEREAS, upon assumption into office of this administration, the Local School Board has been reorganized to adapt to changes brought about by the new set of local officials and DepED personnel, and to provide smooth and orderly formulation of policies by the new set of LSB members;

WHEREAS, to give a better and clear emphasis on bureaucratic cooperation to expedite in resolving matters in the field of education with the help of the local government, key officers must be included to participate in policy making and be given an avenue to contribute to the board's effective formulation of education programs, projects and activities on the vision of an educated citizenry through Responsive Local Governance. Thus, the inclusion of the following is hereby imperative: a.) the Municipal Planning and Development Coordinator and b.) the Municipal Budget Officer;

NOW, THEREFORE, I, **RAMIL L. GENTUGAYA**, Municipal Mayor, Monkayo, Compostela Valley, by virtue of the powers vested in me by law, do hereby order **EXPANDING THE COMPOSITION OF THE LOCAL SCHOOL BOARD** of the Municipality of Monkayo, Compostela Valley.

**SECTION II. FUNCTIONS.** Pursuant to Section 99 of Republic Act 7160, the Local School Board shall have the following functions:

- a.) Determine, in accordance with the criteria set by the Department of Education, the annual supplementary budgetary needs for the operation and remittance of public schools within the municipality, and the supplementary local cost of meeting such needs, which shall be reflected in the form of an annual school board budget corresponding to its share of the proceeds of the special levy on real property constituting the Special Education Fund and such other sources of revenue of the Local Government Code and other laws or ordinances may provide;
- b.) Authorize the Municipal Treasurer, to disburse funds from the Special Education Fund pursuant to the budget in accordance with existing rules and regulations;
- c.) Serve as an advisory committee to the Sangguniang Bayan on educational matters such as but not limited to the necessity for and the uses of local appropriations for education purposes; and
- d.) Recommend changes in the names of public schools within the territorial jurisdiction of local government unit for enactment by the Sangguniang Bayan.

**SECTION III. SECRETARIAT**

The Municipal Budget Office shall provide secretariat services for the Local School Board during its meetings.


**SECTION IV. MEETINGS & QUORUM**

The Local School Board shall meet at least once a month or as often as may be necessary upon the call of the Chairperson or the Co-Chairperson.
