AN ORDINANCE AMENDING FURTHERMORE MUNICIPAL ORDINANCE NO. 21-2008, AN ORDINANCE ESTABLISHING A TERTIARY/COLLEGE INSTITUTION IN THE MUNICIPALITY OF MONKAYO, COMPOSTELA VALLEY PROVINCE TO BE KNOWN AS THE MONKAYO COLLEGE OF ARTS, SCIENCES AND TECHNOLOGY (MonCAST), PARTICULARLY SECTION 5. ADMINISTRATION THEREOF, CHANGING THE POSITION OF COLLEGE ADMINISTRATOR INTO A COLLEGE PRESIDENT TO CONFORM WITH CHED MEMORANDUM ORDER NO. 04, SERIES-2007.

Be it ordained by the Sangguniang Bayan of Monkayo, Compostela Valley Province in Session Assembled, that :

SECTION 1. That the position of **COLLEGE ADMINISTRATOR** as contained under Section 5 – ADMINISTRATION - of Municipal Ordinance No. 21-2008 shall be changed into **COLLEGE PRESIDENT** to conform with CHED Memorandum Order No. 04, series-2007. This was also recommended by the Board of Trustees (BOT) of the College per Resolution No. 05-A-2014.

SECTION 2. REPEALING CLAUSE. Any resolution or ordinance whose provision/s are in conflict herewith are hereby repealed or modified accordingly.


SECTION 3. EFFECTIVITY. This ordinance shall take effect upon its approval.


