MUNICIPAL TAX ORDINANCE NO. 2016 – 01

AN ORDINANCE GRANTING FIVE PERCENT (5%) DISCOUNT ON THE UTILIZATION OF WATER BY A SENIOR CITIZEN WHOSE INDIVIDUAL METER IS UNDER HIS/HER NAME, AMENDING FOR THE PURPOSE ARTICLE G – WATER SYSTEM SERVICE FEES AND OTHER CHARGES, OF MUNICIPAL TAX ORDINANCE NO. 2006-01, OTHERWISE KNOWN AS THE MUNICIPAL REVENUE CODE OF 2006 OF THE MUNICIPALITY, BY INCORPORATING ITEM 5 – DISCOUNTS AND PRIVILEGES FOR SENIOR CITIZENS UNDER SECTION 5G.02 THEREOF.

Be it ordained by the Sangguniang Bayan of Monkayo, Compostela Valley Province, in Session Assembled, that :

SECTION 1. TITLE. This ordinance shall be known as SENIOR CITIZEN WATER SYSTEM DISCOUNT ORDINANCE IN THE MUNICIPALITY OF MONKAYO, COMPOSTELA VALLEY PROVINCE.

SECTION 2. DECLARATION OF POLICY. Pursuant to Republic Act No. 7432, as amended, otherwise known as “AN ACT TO MAXIMIZE THE CONTRIBUTION OF SENIOR CITIZENS TO NATION BUILDING, GRANT BENEFITS AND SPECIAL PRIVILEGES AND FOR OTHER PURPOSES”, one of the privileges for Senior Citizens is a grant of minimum of Five Percent (5%) Discount relative to the monthly utilization of water and electricity supplied by the public utilities, thus, the Municipal Government of Monkayo, Compostela Valley Province, in recognition to their contribution towards nation building, hereby provides and grants this privilege as one of the basic social services given in favor of the Senior Citizens.

SECTION 3. AMENDATORY PROVISION. That Item 5 - DISCOUNTS AND PRIVILEGES FOR SENIOR CITIZENS shall be incorporated as additional provision under Section 5G.02 of Article G - WATER SYSTEM SERVICE FEES AND OTHER CHARGES, to be read as follows :

“5. DISCOUNTS AND PRIVILEGES FOR SENIOR CITIZENS. Senior Citizens in this municipality shall be provided, and shall enjoy a minimum of five percent (5%) discount on the monthly utilization of water supply; provided that the individual meters shall be in their names, provided further that their consumption shall not exceed thirty cubic meters (30 cu.m.) of water; provided further that the privilege shall be granted per household regardless of the number of senior citizens therein, subject also to the compliance of the following requirements:

- a. That the concerned Senior Citizen shall apply for the discount in person or thru representative at the Waterworks Operations Unit with proof of age and citizenship
- b. Proof of Billing (water meter shall be in the name of the Senior Citizen for a period of one year)
- c. Proof of Residence”.


SECTION 4. ADMINISTRATIVE PROVISION. For the speedy, smooth and effective implementation of this Ordinance, the Office of the Economic Enterprise Management through the Waterworks Operation Unit, in coordination with the Office of the Municipal Treasurer, shall prepare the prescribed Application Form, and that the Office of the Municipal Mayor through the Office of the Municipal Administrator shall likewise issue the necessary Implementing Guidelines to this effect.


SECTION 5. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval.


