RESOLUTION NO. 11

A RESOLUTION FAVORABLY ENDORSING HONORABLE DOMINGO M. ESTRADA, SANGGUNIANG BAYAN MEMBER, THIS MUNICIPALITY AS REPRESENTATIVE OF THE SANGGUNIANG BAYAN TO THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB).

WHEREAS, Section 43 (a) of Republic Act No. 6975, an Act Establishing the Philippine National Police (PNP) under a reorganized Department of the Interior and Local Government (DILG), and for other Purposes, states that : "there shall be created by the Sangguniang Panglungsod/Bayan in every city/municipality such number of People's Law Enforcement Board (PLEB) as may be necessary: Provided, that there shall be at least one (1) PLEB for every municipality and for each legislative district of the city. The PLEB shall have the jurisdiction to hear and decide citizen's complaints or cases filed before it against erring officers and members of the PNP. There shall be at least one (1) PLEB for every Five Hundred (500) city or municipal police personnel;

WHEREAS, Section 43 (b) of the same Act also provides the composition of the Board, one of whom shall be ANY MEMBER of the Sangguniang Bayan chosen by their respective sanggunian and in relation thereof, this august Body decided to endorse favorably SB Member Domingo M. Estrada, as this Body's representative to the Board.

WHEREFORE, on motion of Sangguniang Bayan Member Raul B. Basañes, duly seconded by Sangguniang Bayan Member Ronald T. Manzano, it was

RESOLVED, as it is hereby RESOLVED, A RESOLUTION FAVORABLY ENDORSING HONORABLE DOMINGO M. ESTRADA, SANGGUNIANG BAYAN MEMBER, THIS MUNICIPALITY AS REPRESENTATIVE OF THE SANGGUNIANG BAYAN TO THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB).
