AN ORDINANCE ADOPTING PROVINCIAL ORDINANCE NO. 46-2017 OF THE PROVINCE OF COMPOSTELA VALLEY, RE AN ORDINANCE MANDATING THE ESTABLISHMENT OF A MUNICIPAL MAN-MADE POCKET FOREST IN THE ELEVEN (11) MUNICIPALITIES OF THE PROVINCE OF COMPOSTELA VALLEY.

Be it Enacted by the Sangguniang Bayan of Monkayo, Compostela Valley Province, in Session assembled, that :

SECTION 1. TITLE. This Ordinance shall be known as AN ORDINANCE ADOPTING PROVINCIAL ORDINANCE NO. 46-2017 OF THE PROVINCE OF COMPOSTELA VALLEY, RE AN ORDINANCE MANDATING THE ESTABLISHMENT OF A MUNICIPAL MAN-MADE POCKET FOREST IN THE ELEVEN (11) MUNICIPALITIES OF THE PROVINCE OF COMPOSTELA VALLEY.

SECTION II. RATIONALE FOR THE ADOPTION OF THE ORDINANCE. Section 6. Implementing Mechanism of Provincial Ordinance No. 46-2017 provides the role of the Municipal LGU in the implementation of the ordinance, it being also that Monkayo, as one of the eleven (11) municipalities of Compostela Valley is the site where Man-made Pocket Forest be established.


SECTION III. EFFECTIVITY. This ordinance shall take effect upon its approval.

ENACTED and PASSED this 26th day of February, 2019 at Monkayo, Compostela Valley Province.
