MUNICIPAL ORDINANCE NO. 2019 – 09

AN ORDINANCE CHANGING THE NOMENCLATURE OF POSITIONS AS HEREIN
STATED UNDER THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE
(MSWDO), THIS MUNICIPALITY.

Be it ordained by the Sangguniang Bayan of Monkayo, Compostela Valley
Province, in Session assembled, that :

SECTION 1. LEGAL BASIS. Pursuant to Section 447. Powers, Duties,
Functions and Compensation of the Sangguniang Bayan, it shall enact ordinances
necessary for an efficient and effective municipal government, and shall determine
the positions, salaries, wages and allowances and other emoluments of officials and
employees. Likewise, the Sangguniang Bayan is empowered to change
nomenclatures of positions in the Plantilla of Personnel of the Municipal
Government.

SECTION 2. POSITIONS AFFECTED IN THE CHANGE OF NOMENCLATURE.
There is hereby approved the change of nomenclature of the position :
ADMINISTRATIVE ASSISTANT II (DAY CARE WORKER II) – SALARY GRADE 8
UNDER ITEM NOS. 3, 4, 5, 6 AND 7 in the Municipal Social Welfare and
Development Office (MSWDO) into ADMINISTRATIVE ASSISTANT II (SOCIAL
WELFARE ASSISTANT) – SALARY GRADE 8 in the same Office, in the Plantilla of
Personnel for CY 2019 of this municipality.

SECTION III. ADMINISTRATIVE PROVISION. The Office of the Municipal Mayor through the Municipal Human Resource Management Office (MHRMO) shall provide for the necessary mechanisms in the implementation of this Ordinance.


SECTION IV. REPEALING CLAUSE. All issuances, memorandum orders whose provision are in conflict thereof, is/are hereby repealed or modified accordingly.

SECTION V. EFFECTIVITY. This Ordinance shall take effect upon its approval.
