AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSE OF V. BOISER STREET FROM CORNER MATILLOSA AND V. BOISER STREETS (MDRRMO BUILDING) UP TO CORNER V. BOISER – LINGAYA STREETS FROM AUGUST 5-8, 2019 IN VIEW OF THE PAGABAWAN FESTIVAL OF POBLACION, MONKAYO, COMPOSTELA VALLEY.

Be it ordained by the Sangguniang Bayan of Monkayo, Compostela Valley Province, in session assembled, that :

SECTION 1. AUTHORITY TO CLOSE ROADS. The Sangguniang Bayan is hereby authorized to close roads pursuant to **Section 21. Closure and Opening of Roads.** - (a) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 which states : “ A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction”

SECTION 2. ROADS TO BE CLOSED. There is hereby temporarily closed from August 5-8, 2019 V. BOISER STREET FROM CORNER MATILLOSA AND V. BOISER STREETS (MDRRMO BUILDING) UP TO CORNER V. BOISER – LINGAYA STREETS FROM AUGUST 5-8, 2019 IN VIEW OF THE PAGABAWAN FESTIVAL OF POBLACION, MONKAYO, COMPOSTELA VALLEY.


SECTION 3. ADMINISTRATIVE PROVISION. The Office of the Municipal Mayor through the Security and Traffic Management Unit (STMU) shall provide the necessary mechanisms in the implementation of this ordinance in coordination with the Sangguniang Barangay of Poblacion, this municipality.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect upon approval.
