AN ORDINANCE AMENDING FURTHERMORE MUNICIPAL TAX ORDINANCE NO. 2018-01 OTHERWISE KNOWN AS THE REVISED MUNICIPAL REVENUE CODE OF 2018, INCORPORATING AS ADDITIONAL PROVISION STATED HEREUNDER, UNDER SECTION 6A.09 –RECORDS OF PERSONS PAYING REVENUE OF ARTICLE A OF CHAPTER VI THEREOF.

Be it enacted by the Sangguniang Bayan of Monkayo, Compostela Valley Province, in Session assembled, that :

SECTION 1. TITLE. This ordinance shall be known as AN ORDINANCE AMENDING FURTHERMORE MUNICIPAL TAX ORDINANCE NO. 2018-01 OTHERWISE KNOWN AS THE REVISED MUNICIPAL REVENUE CODE OF 2018, INCORPORATING AS ADDITIONAL PROVISION STATED HEREUNDER, UNDER SECTION 6A.09 –RECORDS OF PERSONS PAYING REVENUE OF ARTICLE A OF CHAPTER VI THEREOF.

SECTION 2. AMENDATORY PROVISION. There is hereby amended furthermore, by incorporating additional provision under Section 6A.09 -Records of Persons Paying Revenue, of Article A, Chapter VI, of Municipal Tax Ordinance No. 2018-01 otherwise known as the Revised Municipal Revenue Code of 2018, to wit :

*“The Municipal Treasurer shall furnish the Municipal Accountant’s Office a duly certified list of persons/establishments paying municipal business permit and fees who opted to pay their fees and charges on instalment as allowed by existing ordinance for the establishment of Business Permit Receivable Account”.*

SECTION 3. EFFECTIVITY. This Ordinance shall take effect upon its approval.


