A RESOLUTION REQUESTING THE NATIONAL COMMISSION ON
INDIGENOUS PEOPLES (NCIP) TO FURNISH THE LGU OF MONKAYO
CERTIFIED LIST OF THE TOTAL IP/ICC POPULATION BASED ON AVAILABLE
RECORDS.

WHEREAS, members of the Indigenous Peoples (IPs) of Mandaya, Mangguawangan, Dibabawon and Manobo, and Kalagan of origin comprised about 20% of the total population of the municipality;

WHEREAS, records of the municipality do not tell the exact or estimated population per barangay;

WHEREAS, such population will be utilized in the determination of the minimum threshold of Indigenous Peoples (IPs)/Indigenous Cultural Communities (ICCs) who will be entitled to a seat in the sanggunian pursuant to Republic Act No. 8371 or the IPRA Law of 1997;

WHEREAS, this august Body feels that some of the barangays in the municipality does not meet the required threshold of IP/ICC Population thus there should be no IP Sectoral Representation in the sanggunian;

WHEREAS, to implement and ensure the compliance of these guidelines, the members of the august Body needs the said list as provided for in Joint Memorandum Circular No. 001-2011 of the DILG and the NCIP.


WHEREFORE, on motion of Sangguniang Bayan Member Raul B. Basañes, duly jointly seconded by Sangguniang Bayan Members Domingo M. Estrada and Miguel R. Labrador, it was
