WHEREAS, administration of the Senior High School (SHS) Department of the Monkayo National High School (MNHS) through Mr. Randy M. Villacorteza, Principal II, appeared before the august Body seeking support for the Establishment of a Stand-Alone Senior High School (SHS) in Monkayo, Compostela Valley Province;

WHEREAS, during the plenary, Mr. Villacorteza justified that the School is compliant with the Department of Education’s (DepEd) requirements of being a Stand-Alone High School, for one, it has a separate School Site, School Buildings with facilities and laboratories, it has a separate budget for Maintenance and Other Operating Expenses (MOOEs) from the Monkayo National High School – Junior High School, and with its functional organizational structure, administrative and technical expertise of its Faculty Members, it can operate independently.

WHEREAS, the first of its kind in Compostela Valley once approved, the members of the august Body acceded to its request.


