WHEREAS, copy of Executive Order No. 11 dated April 16, 2019 issued by the Punong Barangay of Olaycon, this municipality, re an Order reorganizing the Barangay Peace and Order Council (BPOC), was presented for confirmation /approval;

WHEREAS, the review of said Executive Orders by the Sangguniang Bayan is in accordance with its Powers, Duties and Functions as stipulated under Sub-Section (1) (i) of Section 447 of the Local Government Code of 1991, which states that :

“Section (1). Approve ordinances and pass resolution necessary for an efficient and effective municipal government, and in this connection, shall :

- (i) *Review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay”.*

WHEREAS, after a brief deliberation, the members of the august Body decided to confirm the said Executive Order, passage of which being in accordance with law;




