INVITATION TO BID FOR THE PROCUREMENT OF FUEL FOR MAYOR'S OFFICE USE AND FOR MASSIVE BARANGAY- BASED DRR-CCA

The Municipality of Monkayo, through the GENERAL FUND 2022 intends SIX HUNDRED THIRTY-SIX THOUSAND ONE HUNDRED SIXTY-FOUR PESOS 25/100 ONLY (PhP. 636,164.25) being the ABC to payments under the contract for PROCUREMENT OF FUEL FOR MAYOR'S OFFICE USE AND FOR MASSIVE BARANGAY- BASED DRR-CCA /PB-2022-027. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Municipality of Monkayo, Davao de Oro now invites bids for the above Procurement Project. Delivery of the Goods is required by (15) days. Bidders should have completed, within (1) year from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from Municipality of Monkayo and inspect the Bidding Documents at the address given below during weekdays from 8:00am to 5:00pm, except for holidays and declared non-working holidays.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
