EXECUTIVE ORDER NO. 2022 - 002

PROVIDING FOR THE REORGANIZATION OF THE GRIEVANCE COMMITTEE OF THE LOCAL GOVERNMENT OF MONKAYO, DAVAO DE ORO

WHEREAS, the settlement of grievance in the public sector shall be resolved expeditiously at all times at the lowest level in the agency. All the agencies are mandated to establish a grievance machinery and mechanism to address grievance among government officials and employees;

WHEREAS, pursuant to Resolution No. 010113 dated January 10, 2001 issued by the Civil Service Commission (CSC) adopts the Revised Policies on Grievance Machinery which seeks to promote harmony in the workplace, thereby fosters productivity of each member of the organization. These policies developed and refined in consultation with employee associations and other sectors of government;

WHEREAS, a grievance shall be settled expeditiously in the lowest level. However, if not settled thereat, an aggrieved party shall present his or her grievance step by step following the hierarchy of positions. Wherein, all agencies shall establish a grievance mechanism and machinery that is the best way to address the same between government officials and employees;

WHEREAS, the aggrieved party shall be assured freedom from coercion, discrimination, reprisal and biased action on grievance. As such, the local government under this administration guided consistently with the thrusts of Responsive Local Governance and in accordance with existing regulations created its Grievance Committee by virtue of Executive Order No. 2017-035 dated June 16, 2017 and was consequently reorganized under Executive Order No. 2020-046;

WHEREAS, to adopt to recent changes in the bureaucracy and other developments in the local government systems and personalities involved, a reorganization is now deemed and considered to be imperative. Further, upon the assumption of new set of Employees' Union Officer, there is a recommended representation from the said employees' group. Hence, this reorganization.

NOW, THEREFORE, I, RAMIL L. GENTUGAYA, Municipal Mayor, Municipality of Monkayo, Davao de Oro, by virtue of the powers vested in me by law, do hereby ORDER PROVIDING FOR THE REORGANIZATION OF THE GRIEVANCE COMMITTEE OF THE LOCAL GOVERNMENT OF MONKAYO, DAVAO DE ORO
