1.The Municipality of Monkayo, through the General Fund 2022 intends to apply the sum of FOUR HUNDRED THOUSAND EIGHT HUNDRED SIXTY FOUR PESOS ONLY (PHP. 400,864.00) being the ABC to payments under the contract for PROCUREMENT OF MEDICAL, DENTAL AND LABORATORY SUPPLIES AND INSTRUMENT FOR VARIOUS PROGRAM/ PB- 2022-0132. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2.The Municipality of Monkayo, Davao de Oro now invites bids for the above Procurement Project. Delivery of the Goods is required by (15) days. Bidders should have completed, within (1) year from the date of submission and receipt of bids, a contract similar to the Project.

4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act"

5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

6. Interested Bidders may obtain further information from Municipality of Monkayo and inspect the Bidding Documents at the address given below during office hours.

A complete set of Bidding Documents may be acquired by interested Bidders on August 9, 2022 (8:00am-5:00pm) to August 15, 2022 (8:00am - 5:00pm) from the given address and below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Five Hundred Pesos Only (500.00)

It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that the bidders shall pay the nonrefundable fee for the Bidding Documents not later the Submission of their bids.

7. Bids must be delivered to the address below on or before August 16, 2022 ; 1:00PM. All Bids must be accompanied by a bid security in a form of , Cash or Cashier's/ Manager's check equivalent to 2% of ABC, or Bid Securing Declaration.

Bid opening shall be on August 16, 2022 ; 2:00PM at Municipal hall, Government Center, J. Martin St. Poblacion, Monkayo, Davao de Oro. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
