3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from Local Government Unit of Monkayo, Davao de Oro and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm weekdays, except for holidays and declared non-working holidays.

5. A complete set of Bidding Documents may be acquired by interested bidders on October 15, 2022 to November 8, 2022 from the given address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Four Thousand five hundred Pesos Only (4,500.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before November 8, 2022 ;1:00 PM. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.

9. Bid opening shall be on November 8, 2022; 2:00 PM at Municipal Hall Building, Government Center, J. Martin St. Poblacion, Monkayo, Davao de Oro. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. On the opening of bids, representatives of bidders must present proof of authority (Special Power of Attorney).

The Local Government Unit of Monkayo, Davao de Oro reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
