The Municipality of Monkayo, through the GENERAL FUND (20% DEVELOPMENT FUND) intends to apply the sum of ONE MILLION FOUR HUNDRED FIFTY-ONE THOUSAND SE ONLY (PHP. 1,451,704.00) being the ABC to payments under the contract for PROCUREMENT OF CONSTRUCTION MATERIALS AND OTHER SUPPLIES AND MATERIALS FOR IMPROVEMENT OF PORTABLE WATER SUPPLY SYSTEM AT PURGATORYO RESETTLEMENT SITE / PB- 2022-0191. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Municipality of Monkayo, Davao de Oro now invites bids for the above Procurement Project. Delivery of the Goods is required by (15) days. Bidders should have completed, within (1) year from the date of submission and receipt of bids, a contract similar to the Project.

4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184,

otherwise known as the "Government Procurement Reform Act"

5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

6. Interested Bidders may obtain further information from Municipality of Monkayo and inspect the Bidding Documents at the address given below during office hours.

7. The Municipality of Monkayo will hold a Pre-Bid Conference on NOVEMBER 22, 2022; 2:00 PM at Municipal hall building, Government Center, J. Martin St. Poblacion, Monkayo, Davao de Oro. Which shall be open to all interested parties.
